Ghyllside School is a Company Limited by Guarantee and is governed in accordance with its Articles of Association registered with Companies House.

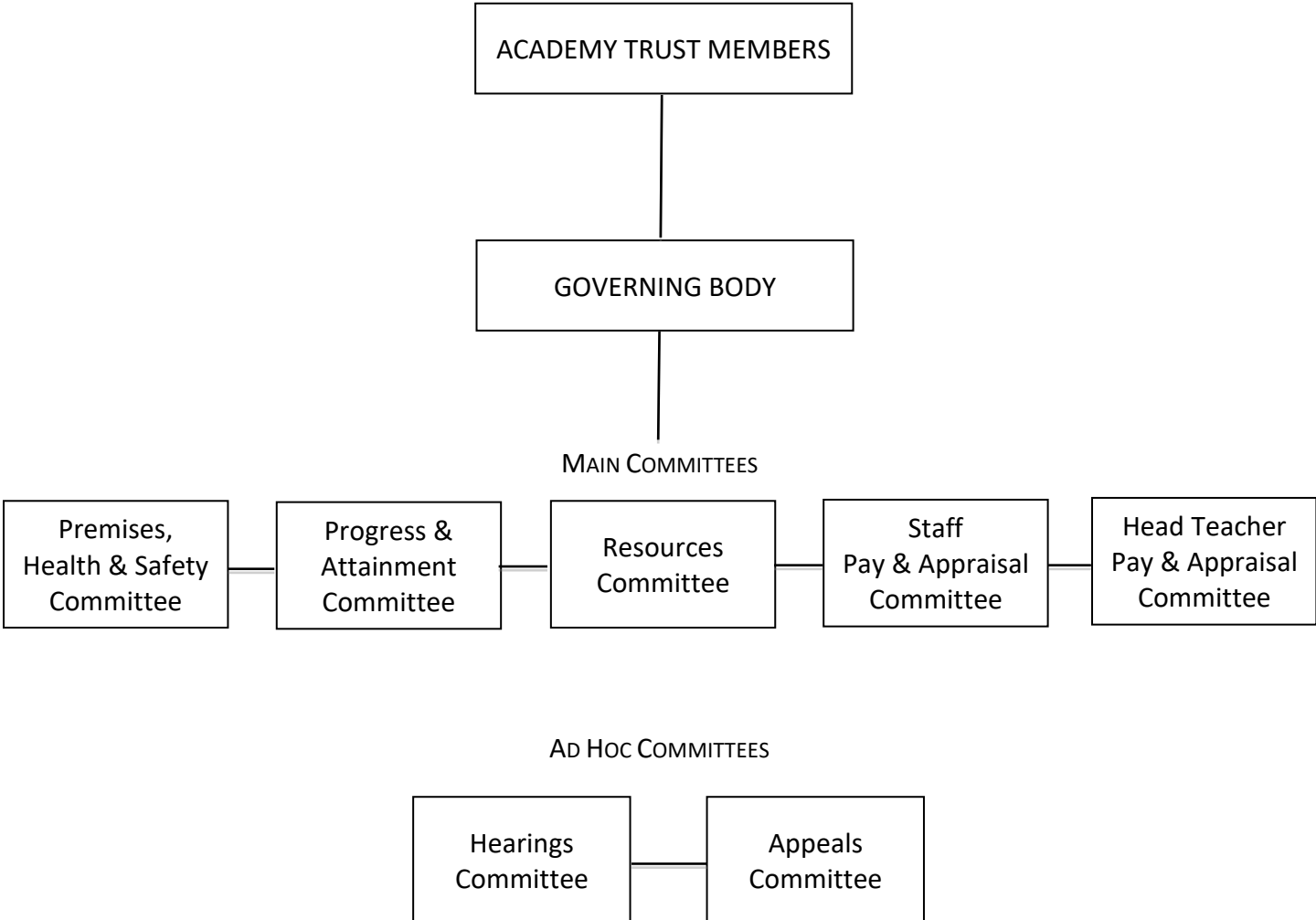
Currently, there are 5 Members of the Academy Trust, together with provision for the following categories and numbers of Governors:
